### **CCA-Why?**

The purpose of the CCA program is to protect the public, farmers and the agricultural industry as a whole. These programs are voluntary, professional certifications to Advisers – proving their commitment to their clients, their employers (*you*), and to the public welfare. Farmers can depend on that determination and commitment for true results in the field.

All successful certification programs have one common element, and that is to serve and protect the public interest. Many professions require a license to practice such as in medicine, engineering, and accounting. A license is basically a certification program offered by the state. Certification programs offered by ASA are voluntary, but offer similar benefits as licensing programs. The ASA certification programs set higher standards for knowledge, skill and conduct within the field of agronomy - a higher standard you can depend on.

#### Steps a CCA Takes for You:

- CCAs are required to pass two comprehensive exams covering nutrient management, soil and water management, integrated pest management, and crop management.
- CCAs are required to have at least two years of documented crop advising experience with a bachelors degree and grower references.
- CCAs must sign and adhere to the CCA code of ethics; meaning, they always focus on integrity and profitability while optimizing and protecting our natural resources.
- CCAs are required to earn 40 hours or more of continuing education every two years. CCAs always have the latest information on new technology and industry developments.

#### **About the Program**

CCA is a certification program of the American Society of Agronomy (ASA). ASA established the certification programs more than 20 years ago to provide a benchmark for practicing agronomy professionals.
